## ABOUT FACULTY OF LAW

## WHAT MAKES US STAND OUT?

- Academic Excellence:** The faculty has signed MOUs with the National University of Study and Research in Law, Ranchi; CUTS Institute of Regulation and Competition, New Delhi; and the Ranka Charitable Trust, governed under the guidance of Justice J.K. Ranka, former judge of the Rajasthan High Court. As part of its mission of providing a holistic learning experience, the faculty has also organised the 7th SGTU National Moot Court Competition, 2023, in collaboration with the Competition Commission of India, and the 1st SGTU-Ranka National Trial Advocacy Competition, 2023, in collaboration with Ranka Public Charitable Trust and International Conference in collaboration with CUTS. The faculty takes guidance from its Industrial Advisory Board, which comprises various academicians, industry experts, members of the bar, and reputed law firms. To develop a social outlook, they also have students participate in legal aid awareness campaigns and provide free legal aid services
- Diversity and Inclusion:** Students get a chance to work and interact with people from all over the country, and the knowledge and diverse perspectives available contribute significantly to their growth.
- Research and Innovation:** The faculty supports student and faculty research through the establishment of various centres including the Judicial Cell, Cyber Cell, Centre for ADR, Centre for Women, Child & Gender Justice, Centre for Advanced Legal Studies, Training & Research, Centre for Criminal Justice, and Centre for Research in IPR. Students conduct a broad range of research for publications in reputable legal journals, moot court competitions, and other purposes. Additionally, the Faculty of Law publishes the SGTU Law Journal and its monthly E-newsletter Law Spectrum.
- Global Opportunities:** The university has international tie-ups on teaching and research aspects, including the promotion and development of academic collaborations. The faculty itself conducted a student exchange program with Western University, Sydney.
- Career Services and Industry Partnerships:** Students are sent for internships regularly under judicial officers, advocates on record, senior advocates, NHRC, CCI, DALSA, and NALSA. Industrial experts are being invited to the Faculty of Law, SGTU, to interact with the students, including Supreme Court and High Court judges, reputed personalities from various government organizations, advocates, and academicians. The students regularly visit the Parliament, Supreme Court of India, High Courts, Police Stations, Tribunals, Cyber Cells, and other related institutions.
